<u>SUMMARY</u>: Under the supervision of the Shelter Manager, this position is responsible for maintaining a safe and sanitary facility for animals and people, and provides humane handling and care for all shelter animals. Assures all animal's nutritional, housing, and basic medical needs are met on a daily basis. Assists the public when admitting and adopting animals and promotes responsible pet ownership in conversations with clients and visitors. Works closely in a team effort with other staff members and volunteers; performs a variety of duties as needed. Must have the ability to be certified as an Animal Control Officer in the State of Texas within 12 months of employment.

SUPERVISION RECEIVED AND EXERCISED

Receives close supervision from Shelter Manager; is further supervised by Animal Control Director and Commissioner's Court.

Exercises no supervision.

ESSENTIAL DUTIES AND RESPONSIBILITIES include the following:

- 1. Responsible for all duties related to the care of shelter animals, including cleaning of kennels, holding areas, yard areas, and general housekeeping duties inside the Shelter facility.
- 2. Assures that animals receive food and water, bathing and grooming as needed, and provides humane handling when animals need to be moved.
- 3. Observes and evaluates animals for signs of illness and reports symptoms to appropriate personnel. Humanely administers medications and/or vaccinations, and performs euthanasia according to BCAC policies and procedures.
- 4. Updates, edits, and corrects data files on animals in the kennels. Maintains accurate records and accesses information related to animal case files, supply inventories, pharmaceutical use data, and animal inventory.
- 5. Assists clients who are seeking lost pets and those who are interested in adopting. Responds to questions about specific animals and the adoption process.
- 6. Performs general maintenance duties to include repairs and upkeep of facility. Assists with maintaining proper inventory and restocking of supplies. Runs errands as instructed.

- 7. Serve as example to other kennel staff and provide guidance to them in following best practices in animal health care and facility maintenance ensuring a clean and professional environment throughout the kennel and exercise yard areas. Exercises limited supervision of shelter staff whose duties include the primary care of animals housed in the shelter kennels. Works with the Animal Control Director in order to ensure that proper standard operating procedures and protocols are being followed by staff.
- 8. Take key responsibility for kennels being kept up to date and correct in terms of having appropriate kennel cards on all doors and that key information is included on them. This information will include but is not limited to hold status, availability and health and behavior information.
- 9. Observe incoming animals for health and behavior in order to determine their best placement within the shelter kennels.
- 10. Observe and report on kennel space, animal health and behavior issues.
- 11. Works with "health" staff tasked with performing initial intake exams and ensures that animals have been scanned for microchip identification.
- 12. Ensures that kennel staff are exercising and enriching animals in the shelter through walks, exercise time in yards, play time and improving behavior through training to help ensure that they are knowledgeable about individual animal temperaments and improve them as adoption candidates.
- 13. Responsible for maintaining equipment and ensuring that it is properly used, maintained and kept in appropriate locations in all kennel and common shelter areas.
- 14. Ensure that volunteers that are working in the kennel do so in a safe, humane and effective way and communicating issues to appropriate staff and the volunteers themselves as necessary.
- 15. Assist in implementing basic training and behavior modification protocols for animals as well as handling protocols for staff and volunteers.
- 16. Log behavior notes for animals as needed. Ensure that medical issues are being addressed for animals in the kennels in a timely manner.
- 17. Attend workshops and training seminars for continued education in the field of animal care in a shelter environment. Use information learned to educate shelter staff.
- 18. Provide continuous feedback for supervisors to facilitate organizational growth.

OTHER FUNCTIONS: Performs other job related duties as directed by supervisor(s).

Identify signs of animal illnesses, diseases, and injuries;

Perform general cleaning tasks using a variety of chemical and detergent products;

Establish and maintain effective working relationships with those contacted in the course of the job;

Perform various manual tasks for extended periods of time and in unfavorable weather conditions;

Work a schedule which may include weekends and holidays;

Perform heavy manual labor;

Operate equipment required to perform essential job functions;

Work independently in the absence of supervision;

Work in a safety-conscious environment and to follow & promote good safety practices;

Learn, understand, and apply pertinent laws, rules, and regulations;

Understand and follow verbal and written instructions;

Communicate clearly and concisely, both verbally and in writing.

Physical Demands:

Effective interaction and communication with others;

Making sound decisions in a manner consistent with the essential job functions.

NOTE: Requires pre-exposure rabies shot series, provided by Bastrop County, within twelve (12) months of employment
