**Brief Job Description:** This position will work with male and female juvenile offenders in a boot-camp style setting. This position is responsible for providing care and control to juvenile offenders by supervising activities, instructing drills and physical training, controlling disorderly offenders, monitoring attendance, inspecting classrooms for contraband, and inspecting cadets' appearances. Will also monitor and evaluate juveniles' progress, assist in the administration of first aide and medications, enforce facility rules and regulations, and assist in all other components necessary in program design for treatment and rehabilitation in Juvenile Boot Camp Program. May be required to perform other duties as assigned by the Program Director and/or Bastrop Juvenile Boot Camp Juvenile Boot Camp Advisory Board.

**Knowledge, Skills, and Abilities:** Must be of good moral character, while possessing the knowledge and ability to lead and participate in physical training; to control offenders' movement within the facility; to restrain juveniles when required; and to ensure adherence to safety requirements. Must be skilled in the administration of First Aid and CPR, and possess the ability to administer medications when needed. Must be skilled in the proper use of English grammar, punctuation, and spelling; and be able to communicate effectively both orally and in writing. Must possess the ability to complete and update logs and forms, and to maintain the confidentiality of the program at all times.

**Minimum Qualifications:** Must be twenty-one (21) years of age or older; must possess a high school diploma or equivalent; no recent or extensive use of illegal substances; and must not have a felony criminal record. Must be drill instructor certified or eligible for certification. Military experience will be helpful.

**Physical Demands:** Includes frequent walking, standing, sitting, squatting, bending, and kneeling. Work activity will be both indoors and outdoors, including seasonal climate changes, with possible exposure to inclement weather.

## **Job Description**

**Job Title:** *Juvenile Boot Camp Drill Instructor*

**Department:** Juvenile Probation Boot Camp

**FSLA Status:** Non-Exempt

**Reports To:** Program Director

**SUMMARY:** Under the direct supervision of the Juvenile Probation Boot Camp Program Director, this position involves working with male and female juvenile offenders in a boot-camp style setting, while offering leadership, guidance and moral principles to at risk youth offenders. This position is responsible for providing care and control to juvenile offenders by supervising activities, instructing drills and physical training, controlling disorderly offenders, monitoring attendance, inspecting classrooms for contraband, and inspecting cadet's appearances. This position also assists the juvenile courts and the (4) four school districts in the community with holding the assigned at-risk youth offenders accountable for their delinquent behaviors.

### **SUPERVISION RECEIVED AND EXERCISED:**

Receives supervision from the Juvenile Probation Boot Camp Program Director

Exercises supervision of juvenile offenders

**ESSENTIAL DUTIES AND RESPONSIBILITIES** include the following:

1. Leads and participates in physical training drill exercises;
2. Controls disorderly offenders;
3. Supervises juveniles activities;
4. Inspects juveniles appearances;
5. Inspects classrooms for contraband;
6. Monitors juveniles attendance;
7. Controls juvenile offenders movement within the facility;
8. Restrains juveniles when required;
9. Ensures juveniles adherence to facility rules and safety requirements;
10. May administer First Aid, CPR, and various medications when needed;
11. Enforces rules established by the Boot Camp Advisory Board;
12. Ensures Department compliance with all federal, state and local laws as they pertain to juveniles;
13. Completes and updates logs and forms;
14. Analyzes data and prepares reports;
15. Works as part of a team and maintains a cooperative, helpful attitude towards fellow workers, supervisors, subordinates, and the general public;
16. Maintains confidentiality and security of all Juvenile Probation Boot Camp information at all times;
17. Performs related work or duties as assigned by supervisor.

**OTHER FUNCTIONS:** Regular attendance is an essential job requirement. Performs other job related duties as directed by supervisor(s).

**NOTE:** The essential functions describe the general nature and level of work being performed by employees holding this position. This is not intended to be a comprehensive listing of all duties and responsibilities required, nor are all duties listed necessarily performed by any one employee so classified.

**MINIMUM QUALIFICATIONS:** To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. Drill Instructor Training;  
Leadership techniques;  
Safety requirements necessary in a controlled environment;  
Proper English usage, spelling, grammar and punctuation;  
Personal Computer skills;  
Standard office policies, procedures, and equipment;  
Applicable laws as related to the operation of the agency; Cen-Tex Juvenile Probation policies and procedures; Rules established by the Boot Camp Advisory Board.

**Ability to:**

Perform drill exercises as required by juvenile offenders;  
Perform multiple tasks simultaneously in a timely manner;  
Communicate clearly and concisely, both verbally and in writing; Understand and follow verbal and written instructions;  
Maintain good moral character;  
Properly interpret, understand and make decisions in accordance with laws, regulations and policies;  
Function independently, exercise good judgment, manage multiple projects, and meet deadlines;  
Establish and maintain effective working relationships with those contacted in the course of the job;  
Demonstrate personal communication skills including effective telephone skills and public speaking;  
Operate equipment required to perform essential job functions;  
Work independently in the absence of supervision;  
Work in a safety-conscious environment and to follow and promote good safety practices;  
Handle exposure to potentially hostile individuals;  
Maintain confidentiality of information encountered in work activities at all times.

**Physical Demands:**
