BRIEF JOB DESCRIPTION: Responsibilities for this position include ensuring the smooth operation of the food service program for the Bastrop County Jail, and for providing nutritious, wholesome meals to inmates and staff. Includes direct supervision of inmates in the preparation of meals for the jail facility, and responsibility for the proper cleaning and maintenance of the kitchen area and equipment. The product of the employee's work affects the operation of the Department, and the well-being of persons other than Bastrop County employees.

GENERAL KNOWLEDGE, SKILLS AND ABILITIES: Must possess knowledge of the operational requirements of a full-service kitchen, including nutritionally sound food preparation procedures for institutional cooking. Must be able to select and supervise skilled inmate labor, with the ability to organize people and work procedures. Must have comprehensive knowledge of health protection and sanitary food handling procedures and requirements. Must have the ability to operate and cook with institutional food service equipment. Must possess excellent verbal and written skills.

<u>MINIMUM QUALIFICATIONS:</u> Must be a TCOLE licensed Jailer or the ability to obtain one. Experience in large quantity food preparation is preferred but not required. Applicant must be able to acquire a food handler's license that is required by the Texas State Health Department.

<u>SELECTION PROCESS</u>: Candidates must submit a letter of interest, and a resume to Captain Lisa Miller by 5:00pm on the closing date. Candidates will be selected by administrative review based on experience, training, productivity, and performance appraisals.

A cover letter and resume is all that is required. The BCSO application is not required for this position.
