**Reports To:** Bastrop County Development Services Director/County Engineer

**SUMMARY:** This position performs administrative tasks in Development Services and Sign Shop. Work tasks include assisting the Sign Shop Manager in the fabrication of signs and requisitioning sign shop materials as needed to properly maintain various sign types for Bastrop County infrastructure.

**SUPERVISION RECEIVED AND EXERCISED:**

Receives supervision from Bastrop County Development Services Director/County Engineer.  
Receives direction from the Sign Shop Manager.  
Exercises no supervision.

**ESSENTIAL DUTIES AND RESPONSIBILITIES** include the following:

1. Use GIS mapping software for research, mapping, and recording geographic information;
2. Design signs using accepted standards and sign design software;
3. Performs fabrication of traffic signs and other infrastructure signs;
4. Requisitions the necessary supplies and materials for sign fabrication;
5. Provides exceptional customer service to County employees and the public;
6. Works as part of a team and maintains a cooperative, helpful attitude towards fellow workers, supervisors, and the general public;
7. Maintains confidentiality and security of all Engineering and Development information and systems;
8. Performs related work or duties as assigned by supervisor.

**OTHER FUNCTIONS:** Performs other job related duties as directed by supervisor(s). **Regular attendance is considered an Essential Function of this position.** **NOTE:** The essential functions describe the general nature and level of work being performed by employees holding this position. **Ability to:**

Communicate clearly and concisely, both verbally and in writing;  
Understand and follow verbal and written instructions;  
Complete routine business correspondence;  
Effectively speak to small audiences to convey information;  
Properly interpret, understand and make decisions in accordance with laws, regulations and policies; Conduct business with the public in a professional, courteous manner;  
Function independently, exercise good judgment, manage multiple projects, and meet deadlines; Establish and maintain effective working relationships with those contacted in the course of the job; Demonstrate personal communication skills including effective telephone skills and public speaking; Operate equipment required to perform essential job functions;  
Work independently in the absence of supervision;  
Work in a safety-conscious environment and to follow and promote good safety practices;  
Handle exposure to potentially hostile individuals;  
Maintain confidentiality of information encountered in work activities at all times.

**Physical Demands:**
